NOMINATION CRITERIA

Executive Management Committee

Only those elected to "FULL" membership status as stated in Section B, paragraph (1) & (2) of the Constitution are eligible to nominate and hold the following positions on the Executive Management Committee: -

President
Senior Vice President
Treasurer

Committee Person

Those members who are elected to the status of "Full" membership as stated in B, paragraph (1) & (2) and "Associate and Corporate" membership as stated in Section C, are eligible to nominate for and hold the positions of "Junior Vice President, Secretary or Committee Person" for which there are five (5) positions. Only two of the above positions are open to Corporate or Associate members in any one year.

Term of Office

The term of office for all the positions on the Committee of Management are for a period of Two (2) years, as described in the Constitution.

The position of the President and Secretary are to be up for election on alternate years, with the rest of the committee being elected in two (2) halves on alternate years.

This is so the Committee does not allow all its experienced people to vacate the Committee all at once, and allows the remaining people to assist the newly elected members of the Committee.

Help plan the future of the supervisory officers role, and become part of the Team, and join the State Committee of your Association. With your assistance we can improve our standing in Local Government and other related civil construction industries.
